Sir,

Please refer to you RTI application dated 15 October 2019 addressed to Ministry of Defence, which was transferred to RTI Cell, Ministry of External Affairs, New Delhi.

2. The response to your query is as follows:

There is no commonly delineated Line of Actual Control (LAC) in the border areas between India and China. From time to time, on account of differences in the perception of the LAC, situations have arisen on the ground that could have been avoided if we had a common perception of the LAC.

Government regularly takes up any transgression along the LAC with the Chinese side through established mechanisms including border personnel meetings, flag meetings, meetings of Working Mechanism for Consultation & Coordination on India-China Border Affairs, as well as through diplomatic channels.

Other queries in your RTI request do not pertain to the undersigned CPIO. They are being transferred to Ministry of Defence, PAI and L&T Divisions of MEA.

3. If you are aggrieved with this reply, you may file an appeal to Dr. Amit Telang, Director (East Asia) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi - 110011, within a month from the date of receipt of this letter.
