Sir,

Please refer to your RTI application dated 20 August 2019 addressed to President's Secretariat, which was transferred to RTI Cell, Ministry of External Affairs, New Delhi.

2. The response to your query with respect to Point No. 3 of your query is as follows:

China is under occupation of approximately 38,000 sq. Kms of Indian territory in the Union Territories of Jammu & Kashmir and Ladakh. In addition, under the so-called China-Pakistan "Boundary Agreement" signed between China and Pakistan on 2 March 1963, Pakistan illegally ceded 5,180 sq. kms. of Indian territory in Pakistan Occupied Jammu & Kashmir to China.

The fact that Jammu & Kashmir and Ladakh are an integral and inalienable part of India, has been clearly conveyed to the Chinese side on several occasions, including at the highest level.

3. For other parts of your query, your RTI application is being transferred to Ministry of Defence for appropriate action.

4. If you are aggrieved with this reply, you may file an appeal to Dr. Amit Telang, Director (East Asia) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi – 110011, within a month from the date of receipt of this letter.




