Señor Ministro:

Tengo el honor de dirigirme a Vuestra Excelencia con el objeto de proponer a su Gobierno, en nombre del Gobierno argentino, un Acuerdo de reciprocidad entre nuestros dos países, concerniente a la supresión de visados para los titulares de pasaportes diplomáticos y oficiales, bajo las siguientes disposiciones:

1- Los nacionales argentinos e indios, titulares de pasaportes diplomáticos y oficiales válidos de su nacionalidad, quedarán exentos de visado para ingresar a la República de la India y a la República Argentina, respectivamente, cualquiera sea la causa del viaje.

- 2- Los titulares de los pasaportes antes mencionados, podrán permanecer hasta tres meses en el territorio indio o argentino, con reingresos múltiples. Este plazo podrá ser prorrogado por las autoridades competentes de cada país, por un período igual.
- 3- Los titulares de pasaportes diplomáticos y oficiales que presten servicio en las respectivas Misiones Diplomáticas y Consulares y hayan sido acreditados como miembros de su personal, podrán ingresar, permanecer y salir libremente del país en el cual presten servicios, durante el tiempo que desempeñen su cargo.
- 4- La supresión de visados establecida por el presente Acuerdo, no exime a los titulares de dichos pasaportes de la observancia de las leyes y reglamentos en vigor relativos al ingreso, la permanencia y la salida de los respectivos países.
- 5- Ambos Gobiernos se reservan el derecho de restringir el ingreso a su territorio, cuando consideren inconveniente la entrada al país de una persona determinada.
- 6- Cualquiera de las Partes podrá denunciar el presente Acuerdo mediante aviso previo de tres meses, por la vía diplomática.

Si lo antes expuesto fuese aceptable para el Gobierno de la República de la India, esta Nota y la de respuesta de Vuestra Excelencia donde conste dicha conformidad, constituirán un Acuerdo entre nuestros dos Gobiernos, sobre la materia, el cual entrará en vigor en el día de su Nota de respuesta.
