The complaints can be in cases related to murder, rape, trafficking, any kind of sexual abuse, extortion or any other illegal crimes committed in the host nations by the Peacekeeping forces SINCE THE YEAR 1990 TILL DATE.

Information Sought:

- 2. Kindly furnish the total number of such complaints where investigations were initiated against such Indian UN Peacekeepers, troops or employees. ALSO, MENTION the year such complaints were received and the year when investigations were initiated. Kindly mention for each year since THE YEAR 1990 TILL DATE.
- 3. Kindly furnish the total number of such complaints where investigations were completed.
- 4. Kindly furnish the total number of investigations that are still pending and since how long.
- 5. Kindly furnish the total number of complaints where investigations led to convictions.
- 6. Kindly furnish the total number of complaints where investigations led to acquittals or cases were closed.

Attention is invited of the CPIO to the fact that no name or sensitive personal

details of the victims or accused has been asked by the applicant. Therefore, legally speaking, there is no harm in providing ONLY THE NUMBERS AND FIGURES as sought. And apart from this, there has been a number of other cases where the figures and numbers of accused or victims have been provided to the public.
