Please refer to your RTI application received in this Division on 09.02.2017. The response to your RTI application is as follows:

2. There are currently six official languages at the UN viz. English, French Chinese, Russian, Spanish and Arabic. While five languages were official languages since inception, Arabic was adopted as official language of UN in 1973.

Indian Government continues to take measures for the acceptance of Hindi as one of the Official Languages of the UN. In light of this objective the 8th World Hindi Conference was organized in New York on I3 July 2007 and its inaugural session was held at the Headquarters which was attended by the UN Secretary General. At the last World Hindi Conference organised in Bhopal from I0-12 Sep 2015 one of the sessions of the Conference was devoted to the theme *Videsh Niti Mein Hindi* ("Hindi in Foreign Policy") in which one of the recommendations reiterated was that Hindi should be made a UN language. A Committee has been established under the Chairmanship of External Affairs Minister for implementation of this and other recommendations made at the Conference.

A World Hindi Secretariat has also been set up in Mauritius in February 2008, to promote Hindi as an international language.

On several occasions Indian leaders have delivered statements at the UN in Hindi including Prime Minister's statement to the 69th UNGA in September 2014, the address of prime Minister to the United Nations Sustainable Development Summit in September 2015, the address to the 70<sup>th</sup> UNGA by External Affairs Minister in October 2015, and the address of External Affairs Minister to the 71<sup>st</sup> UNGA in September 2016. Necessary special arrangements were made for simultaneous interpretation of these statements into English by the Permanent Mission of India in New-York.

The Government continues its efforts in popularizing Hindi worldwide and for the acceptance of Hindi as one of the UN official languages. In this regard, one significant achievement has been the United Nations broadcasting its programmes on the UN Radio Website in Hindi language also. 3.
