India and China agreed to establish a 'Strategic and Cooperative Partnership for Peace and Prosperity' in April 2005. In September 2014, the two countries agreed to build a 'Closer Developmental Partnership' and make this developmental partnership a core component of the Strategic and Cooperative Partnership for Peace and Prosperity.

India and the Republic of Korea agreed to upgrade their bilateral relationship to a 'Special Strategic Partnership' in May 2015.
