
2. The response to your query w.r.t. China is as follows:

This Ministry does not make travel arrangements for traders and only facilitates issuance of travel documents (known as Border Trade Passes) for border trade through the following three land border routes: Lipulekh, Utrakhand; Shipki La, Himachal Pradesh; and Nathu La, Sikkim.

Under a bilateral agreement with the People's Republic of China, Kailash Mansarovar Yatra is organized by this Ministry during June to September each other through two different routes: Lipulekh Pass (Utrakhand) and Nathu La Pass (Sikkim).
