
Sir,


Dear Sir,

Kindly refer your letters dated June, 2016, 22nd August, 2016 addressed to the Department of Pension and Pensioners' Welfare and endorsed to this Ministry regarding revision of your pension after fixing your pay by granting two additional increments in pursuant of Government of India, Ministry of Finance OM No. 1/1/2008-IC dated 29.8.2008.

2. In this regard, it is stated that the instructions contained in the above mentioned OM dated 29.8.2008 is applicable for fixation of pay of the serving government employees who were in service as on 1.1.2006 or after that. Revision of pension of all pre-2006 pensioners is required to be governed by GOI, Department of Pension and Pensioners' Welfare (DOP&PW) OM Nos. 38/37/08-P&PW (A) dated 1st September, 2008 and 28th January, 2013. In this regard, Ministry's letter of even number dated 26th December, 2014 may be referred to.
