
Please refer to your above RTI application dated 6.4.15, seeking details of gifts exchanged between India and other countries. Our reply is given below ad seriatim:

(b) & (c) Though the period mentioned is not clear, in this connection, this is to state that the Prime Minister of India presents gifts, as per the laid down norms, to various foreign dignitaries. Information sought by you relates to details and value/cost of the gifts presented by the PM to the foreign dignitaries. However, disclosure of this information may prejudicially affect India's relations with the concerned foreign State/s. Exemption is, therefore, sought under section 8(1) (a) RTI act 2005, wherein no such information as may prejudicially affect India's relations with a foreign State need be disclosed.
