(e) Memorandum of Understanding between Ministry of New and Renewable Energy, Government of India and Japan Bank of International Cooperation; and (f) Confirmation of the intention regarding the Partner City Affiliation between City of Varanasi (Republic of India) and City of Kyoto (Japan).
