
2. With respect to **para 1 & 3**, it is conveyed that PM Shri. Narendra Modi paid an official bilateral visit to **Australia** (16-18 November, 2014) after attending G20 Leaders' Summit in Brisbane on 15 November, 2014. He visited Sydney, Canberra and Melbourne as part of the bilateral visit. No assistance was declared to Australia during the PM's visit.

3. In case of **Malaysia**, with respect to **para 1 & 3**, it is conveyed that PM Shri. Narendra Modi visited Malaysia in November, 2015 for the India-ASEAN Summit and East Asia Summit related meetings followed by an official bilateral visit from 21-23 November, 2015. No direct assistance was declared to Malaysia during the said visit, however corpus of Rs. 5 crore was declared for the Indian Scholarship Trust Fund (ISTF).

4. Expenditure related information in connection with these visits is not available with this CPIO and therefore this part of RTI is being transferred to Senior Accounts officer (Controller of Accounts) & CPIO for further action under section 6(3) of the RTI Act.

5. In case you are not satisfied with the above reply, you can file an appeal within 30 days from the date of receipt of this communication, under Section 19 (1) of the Right to Information Act, 2005 to the following:-
