Other personal details like address and names of other relatives mentioned in the passport can be severed from the details while providing copies of the passport or the ministry can only provide the list of names of NHK employees/journalists with their father names, designation and category of visa with the purpose and duration of the visit.

Kindly also share the copies of proposals/scripts/pre shoot scripts/outline of television/news programs to be covered by NHK in India to the ministry of external affairs, additional documents and complete record of correspondence including file noting/opinions, clarification sought by the MEA and received by it in this regard.

Please also share true certified copies of any complaints received against NHK by the MEA or its offices.

Please also share complete details of any denial of visa to any NHK journalists or denial of extension of visa to NHK journalists stationed in India or outside India during 01.01.2007 to 31.12.2011.

Please feel free to refer to this application other CPIO/s if the information is more closely connected to them but provide details as expeditiously as possible.
