### **CORRIGENDUM**

Reference Notice inviting Tender No. M (Haj)/1183/01/2014 dated April 29, 2014 for supply of Medicine and Medical Equipment at Consulate General of India, Jeddah for Haj-2014 published on Central Public Procurement Portal.

**2.** In this connection some clarifications/comments may be read as under:

#### Clause No. 4.8:

In case of supply of small quantity of medicines, a sticker bearing "Supply of Jeddah, Not for sale" may be put instead of stamping the items.

# **B.** Analgesic, Antipyretic, Anti-Inflammatory and Anticold Items No. 58

Item no. 58 is required with Capsaicin.

#### Item No. 83:

Item no. 83 doesn't contain Magnesium Aluminum Silicate , however , Item No. 72 contains Magnesium Aluminum Silicate 50 mg.

Any brand from any standard manufacturer which contains all the composition indicated in our indent is acceptable.

#### Item No. 176/177:

Any brand from any standard manufacturer which contains all the composition indicated in our indent is acceptable

#### Item No. 231/232/233:

Latex surgical Gloves

Item No. 231 is required in "no.s" as it is unsterile examination gloves while the item no. 232/233 is required in pairs as it is disposable sterile surgical gloves which comes in pairs.

### (B) Special Clause No.7 :

A quality control certificate/report from the Govt. approved Chemist (Drug Analyst) for all the medicines being supplied may be forwarded along with the medicines, as it is a requirement of the local Health Ministry

### Clarification:

Where a quality control certificate/ analysis report from the govt. Approved lab/chemist/drug analyst is not possible due to smaller quantity, supplier may submit the in-house batch wise analysis report of the manufacturer.

### Section II (A) General 4. Eligible Bidders Clause 4.8:

The strip/Packet/bottle of drugs will be stamped supply to Jeddah/Not for sale

## **Clarification**:

In such cases, supplier may put stickers / stamp of "Supply of Jeddah, Not for Sale"..

### (B) Special Clause No. 12:

Supply of Generic drugs must be avoided.

## **Clarification:**

Quality of the medicines should be ensured by procuring them from reputed manufacturers. It may be noted that Saudi Food and Drug Authority conducts quality control test before the consignment is cleared. Also, the items are checked by Saudi Health Authorities before we are issued license. Often, they conduct quality control test during Hajj.

- **3.** Other terms and conditions of the Tender will remain same.
- **4.** This issues with the approval of the competent authority.
