Kindly refer to your RTI application no. PMOIN/R/2015/61440 dated 06/06/2015 seeking information regarding PM Shri Narendra Modi Foreign visits during his tenure

2. In this regard, with respect to point 5, it is conveyed that in case of **Australia**, PM Shri Narendra Modi paid an official bilateral visit to Australia (16-18 November, 2014) after attending G20 Leaders' Summit in Brisbane on 15 November, 2014. He visited Sydney, Canberra and Melbourne as part of the bilateral visit. Prime Minister Modi held wide-ranging talks with Australian Prime Minister Tony Abbott, addressed a joint sitting of both houses of the Parliament (the first time an Indian prime minister has done so) and met the President of the Senate, the Speaker of the House of Representatives and the Leader of the Opposition in Canberra. He also met political leaders, academics, businesspeople and sporting figures and addressed members of the Australian Indian community.
