8	Earnest Money Deposit
8.1	Earnest Money is not required to be deposited.
9	Performance Bank Guarantee
9.1	Performance Bank Guarantee is waived subject to undertaking by the Supplier that warranty shall be provided against manufacturing defects and free service for a period of one year or 25,000 km whichever is later.
10	Defect Liability Period
10.1	Vehicles to be supplied shall be under warranty period for at least one year from the date of supply of vehicles against all manufacturing defects.
11	Warranty
11.1	The Supplier shall provide warranty of vehicles against manufacturing defects and free service for a period of one year or 25,000 km whichever is later or more if provided by manufacturer.
12	Liquidated Damages
12.1	In case of delay in delivery of vehicles by the stipulated date, the Supplier is liable to pay delayed charges @0.5% of the value of supply order for each week of delay. Delayed charges shall be limited to 10% of the value of supply order.
13	Currency
13.1	All rates shall be quoted in Indian Rupees (INR) or in West African CFA Franc (CFA) or in US Dollars (US\$).
14	Period of validity of bids
14.1	Bids shall be valid for a minimum period of 120 days from the date of submission.
15	Number of bids per bidder
15.1	Each bidder shall submit only one bid. A bidder who submits more than one bid shall be disqualified.
16	Deadline for submission of bids
16.1	Bids must be received by the Buyer before the due date and time at the address specified in the tender document.

17	Amendment of bidding document

Opening of bids by the Buyer
The technical bids will be evaluated by the Buyer to shortlist the eligible bidders.
Financial bids shall be opened in the Embassy of India, Bamako at 1500 hrs on 1 February 2019.
Bidder whose Technical Bid is found to be acceptable and meeting the eligibility requirements as specified in "Clause 5" will be invited by the Buyer to be present during opening of Financial Bids.
Buyer will open Financial Bids of only the technically accepted and short listed bids, in the presence of the bidder or their authorized representative who choose to attend the bid opening, at the time and date informed by the Buyer.
The bidder's name, bid prices, warranty of vehicles and other such details as considered appropriate by the Buyer will be announced at the time of opening of Financial Bids.
Award Criteria
Buyer shall award the contract to the eligible bidder whose technical bid has been accepted and determined as the lowest evaluated Financial Bid.
Buyer reserves the right to award the contract at its own discretion should more than one bidder quote the same lowest price.
Corrupt or Fraudulent Practices
Buyer will reject a bid if it determines that the Bidder recommended for award has engaged in corrupt or fraudulent practices while competing for this contract.
Payment Terms
Payment shall be made either by crossed cheque in favour of the manufacturer / dealer / bidder drawn on State Bank of India, payable at par anywhere in India, or by crossed CFA cheque payable at par at Ecobank, Mali or by bank transfer in US\$ on successful delivery at site of supplies in good condition.
General
All offers shall be either computer prints or hand written neatly in indelible ink. Tenders shall be free from correction and erasures, and corrections, if any, must be attested. Each page of the offer must be numbered consecutively and should be signed by the bidder at the bottom. A reference to the total number of pages comprising offer must be made at the right hand corner of the first page.

AND WHEREAS the Supplier has submitted tender and the Buyer has accepted the tender submitted by Supplier for the total amount of INR / CFA / US\$ \_\_\_\_\_\_ towards basic price of 05 vehicles. In respect to clearing and forwarding charges of the vehicles, the supplier will charge as per actual on production of receipts. No extra amount will be paid for cost of logos/stickers etc. to be affixed on the vehicles.

The whole supply comprised in this Agreement shall be completed **within 60 days** from the date of award of work. The maintenance service provided to maintain the vehicles in good order for the specified Warranty

period from the date of supply shall be in conformity in all respects with provisions of the agreement.

- (ii) **Liquidated Damages**: In case of delay in delivery of vehicles by the stipulated date, the Supplier is liable to pay delayed charges @ 0.5% of the value of supply order for each week of delay. Delayed charges shall be limited to 10% of the value of supply order.
