**FORMAT FOR INDEMNITY BOND FOR GUARANTEED PERFORMANCE**

This deed of indemnity executed by M/s ....., having its registered office at.....hereinafter referred to as 'Agency/ Indemnifier' which expression shall, unless repugnant to the context or meaning thereof, include its successors, administrators, representatives and assignees, in favour of Pravasi Bharatiya Kendra, Ministry of External Affairs, hereinafter referred to as the 'Indemnified', which expression shall unless repugnant to the context or meaning thereof, include its successors, administrators, representative and assignees witnesses as to:

Whereas, the Agency has taken the contract for management and catering services and the work has to be executed by the Agency through its workers and supervisors, further to which M/s ..... (Agency) undertake to indemnify Pravasi Bharatiya Kendra, Ministry of External Affairs, against the following:

- i) All claims for injury or damages or any person or property caused by his negligence or negligence of his employees whilst in PBK Premises
- ii) All claims by way of compensation and all other types of unforeseen claims, which may arise in the course of contract
- iii) The Agency shall accept liability for compensation in accordance with the provision of the Indian Workers Compensation Act 1948, amendments thereafter, and / or other law for the time being in force for personal loss / injury caused to any worker by accident arising out of and in the course of the contract.
- iv) All payments by way of compensation or otherwise, to make under the provisions of the said act to any workmen as aforesaid and any cost incurred by the Pravasi Bharatiya Kendra, Ministry of External Affairs in connection with any claim preferred by such workmen and or against all actions, claims and demands whatsoever in respect thereof or in respect of any loss, injury or damages whatsoever to any third person arising out of or occasioned by the negligence, imperfect or improper performance of the contract by the contractor or their workers.
- v) The Pravasi Bharatiya Kendra, Ministry of External Affairs shall not be held liable for any loss, damage or compensation to any third party (including, but not limited to, property loss and damage, personal accident, injury or death of any person) arising from or in relation to transport operation done, such loss, damages or compensation shall be reimbursed by the Agency together with the costs incurred by the Department on any legal proceedings pertaining thereto Agency.
- vi) All liabilities under Workman's Compensation Act / Fatal Accident Act, Personal Injuries, Employees State Insurance Act, PF Act, etc. in force from time to time shall be responsibility of the Agency.
- vii) All administrative and legal responsibility that may arise out of its operations and services at PBK.

- viii) The Agency shall adhere to, comply with and implement all the relevant and applicable labour, wages/minimum wages and employment Acts, Laws, By-laws and Regulations etc by the government and local government and/or by any other authority/body under law, in respect of the employees deployed by it at PBK. The Agency shall be solely responsible for any breach thereof and liabilities as a consequence, and Ministry of External Affairs shall have no liability whatsoever and stands fully indemnified.
- ix) The Agency shall be solely responsible for any failure to fulfill any statutory obligations and / or his duties during the course of his work at the PBK premises. Agency shall indemnify the Ministry against all such liabilities, which may arise out of the Agency's failure to fulfill such statutory obligations relating to licenses, registrations etc. and/or compensation to his workers or any other party in connection with the food preparation, serving and catering services.
