### **Invitation for bids**

Embassy of India, Beijing invites Bids/Quotations from reputed companies based in China for English to Chinese translation and addition of Chinese subtitles to Indian Movies.

#### 1. Eligibility criteria for bidders:

- (a) The company should have valid/permit/registration from a competent local authority for translation/maintenance/design/technical support/publicity/promotion services particularly in relation to internet/website-based content, for a minimum of 3 years
- (b) The company should be in operation for more than three years.
- (c) The company should have experience in translation and editing of videos for a minimum of 3 years.
- (d) The company should have sufficient number of staff for the proper execution of the job.

### 2. Scope of Work:

#### 3. Bid system:

The company/agency shall submit its offer in the following way:

- (a) First envelope-super-scripted "Technical Bid TRANSLATION AND SUBTITLING OF INDIAN MOVIES INTO CHINESE"
- (b) Second envelope-super-scripted "Financial Bid TRANSLATION AND SUBTITLING OF INDIAN MOVIES INTO CHINESE"
- 4. Both the sealed envelopes shall be kept inside a larger sealed envelope, i.e., in c) Third envelope superscribed as "TRANSLATION AND SUBTITLING OF INDIAN MOVIES INTO CHINESE". It should also be super-scripted at the bottom left corner with the full name, Postal address, Fax, Email, Telephone number of the bidder.

  - (c) The bid may be submitted by hand in person or by courier. The bids by "Fax/E-mail" shall NOT be accepted;
  - (d) Bids received after the closing date and time as prescribed in the tender notice, shall NOT be accepted under any circumstances;
  - (e) Bid shall be opened on the date and time as given in the tender notice at Embassy of India, Beijing, No. 5, Liang Ma Qiao Bei Jie, Chaoyang District, Beijing 100600, in the presence of the authorize representatives of the companies, who may wish to attend.
  - (f) The bid has to be submitted as per the format specified at 'Annexure I & II' respectively.
- 5. **Mode of Payment:** 50% on signing of the contract; balance 50% upon confirming successful completion of work by contracting Party, i.e., Embassy of India, Beijing.
