## **TENDER NOTICE**

The Consulate General of India in Shanghai invites bids from reputed agencies, for design, hosting and maintenance of the website of the Consulate.

### **(I) Broad Scope of work:**

The work would broadly include:

- i. An overhaul of the website design to make its layout more attractive, user friendly and practical, including adapting it to make it mobile phone friendly.
- ii. Maintenance of the Consulate website including portals for Registration of Indians, Students and Commerce wing related to Trade queries and Commercial Attestation for a duration of three [03] years.
- iii. Deployment of a dedicated support team on a 24 x 7 basis.
- iv. Editing & Uploading of content on portal and related webpages. The content may include documents, PDFs, Images, videos, weblinks, etc.
- v. Designing of webpages/modules on special occasions and as per Ministry's requirements. Eg. on the occasion of International Day of Yoga, etc.
- vi. To ensure that the website is GIGW (Guidelines for Indian Government Website) compliant and has the requisite features ensuring accessibility to physically disabled persons. The website should also observe the W3C guidelines available at <https://www.w3.org/WAI/standards-guidelines/wcag/>
- vii. Carrying out security audit of the website and procurement of digital certificates (eg. SSL, website quality certificate etc.) as and when required. The website manager also has to provide and bear the cost of SSL Certificate and the cost may be reflected in financial bid.
- viii. Designing of a URL shortener for the Consulate.
- ix. All website data is to be backed up and retained throughout the period of contract unless there are directions to the contrary, issued by the Consulate General of India in Shanghai. Data retained and backed-up needs to be transferred on request of Consulate General of India in Shanghai.

### **(II) Detailed Scope of Work**

#### **A. Website Design:**

- i. Website must be responsive and will be maintained in English (with added Chinese machine translation link for Chinese, as decided by Consulate General of India) with uniform and user-friendly presentation of the contents.
- ii. Website must be designed, developed, deployed and maintained according to W3C Guidelines and the Guidelines for Indian Government Websites (GIGW).
- iii. The website must be developed using well established technologies preferably Open Source environment without using any third party tool or framework, which may incur any financial implication to the Consulate.

- iv. Hosting will be done on Virtual Private Cloud (VPC). The Agency has to provide VPC services from among the empanelled vendors of Cloud Service providers approved by MeITY.
- v. Compliance of web standards and guidelines issued by Government of India time to time and certification by the STQC, DEITY for GIGW compliance.
- vi. Creation of documents including user and technical manuals.
- vii. Providing training to the users of Consulate as and when required.
- viii. Transfer of Source code and other credentials for the website.
- ix. Responsive design that is aesthetic and modern compatible with all handheld devices and browsers.
- x. At least three design options/templates need to be provided with technical presentation for home page as well as inner pages of the website.
- xi. Upon selection, selected agency will need to provide FRESH designs incorporating inputs from Consulate General of India in Shanghai if any, for website for the Consulate to choose from.
- xii. Consulate will reserve the right to choose and finalise the new design for the website. Redevelopment of the website will start only after the design of the website gets finalized.
- xiii. Design must have Search Engine Optimization (SEO) boosting elements/SEO friendly. Highly user-friendly information architecture (IA) and clear navigation. The Design of the website may undergo changes during the period of contract as per the guidelines of MEA from time to time. The company should make such mandatory changes without any additional cost to the Consulate.
- xiv. Website speed optimization.
- xv. Customization of user interface in terms of color, font size and language, etc.
- xvi. Social Media Integration.

#### **B. CMS Maintenance:**

- i. Maintenance and redevelopment of a customized Content Management System (CMS). CMS must be flexible and scalable to accommodate suggested changes/modifications including design and IA, as and when required during the contract period.
- ii. CMS must have simple workflow and publishing controls.
- iii. CMS should have simple and easy administration.
- iv. CMS must have Search Engine friendly attributes.
- v. CMS must have security features.
- vi. CMS must have robust content templates.
- vii. CMS must support detailed analytics for each section of the website.
- viii. Comprehensive SEARCH functionality on homepage as well as each section of the website. Auto archival mechanism to maintain the archived documents with proper classification and auto archival system.

- ix. Content optimization including images.
- x. Role/Level based access to users for content updates.
- xi. Audit trails of the documents hosted on the website should be maintained and should be accessible to the administrator as and when required.
- xii. Content of each section should be sharable by the user on multiple platforms such as Facebook, Twitter, WhatsApp, Email, etc.

### **C. Website Maintenance:**

The agency has to provide the maintenance support for three [03] years. The contract may be further extendable for a period of two [02] years at a time (with a maximum of two [02] successive extensions) at the discretion of the Consulate. The maintenance work would include the following:

- i. Maintenance of CMS and technical modifications as and when required.
- ii. Creation of new web pages within existing site as and when required.
- iii. Website design changes as and when required.
- iv. Website technical functionality upgrade as and when required.
- v. Monitoring and maintaining website speed, sign up process, navigation links etc.
- vi. To design and upload banners, iQuery, graph artwork, info graphics and audio - video files etc. on the website.
- vii. Formatting and posting of content updates, images, videos etc. on regular basis. Conversion of documents to required format such as HTML/HTMLS.
- viii. Bug fixing and keeping website(s) secured from all possible cyber-attacks and hackers at all time. Cloud flare for enhanced protection against DDOS is also needed.
- ix. Security audit as and when required.
- x. Execution of SEO inputs provided by the Department of Commerce.
- xi. Content upload and website support on 24X7 basis.
- xii. Keeping activity log for all web updates.
- xiii. Creation and maintenance of archive section on the website.
- xiv. Trouble shooting.

### **D. Website Hosting:**

Hosting will be done on Virtual Private Cloud (VPC). The Agency has to provide VPC services from among the empanelled vendors of Cloud Service providers approved by MeITY.

### **(III) Validity & Extension of Contract:**

- i. The contract will be signed initially for a period of three years [03] which may be extended for a further period of two years [02] at a time (with a maximum of two successive [02] extensions) at the sole discretion of the Consulate on the existing terms and with the written consent of the selected agency.
- ii. The agency during the period of contract will carry out changes to the website, without any additional cost to the Consulate, as may be necessary [viz., technical, content, design, security features or other parameters] if and when such changes are mandated by the Ministry of External Affairs, Government of India.

#### **(IV) Pre-bid Meeting**

- i. A prospective bidder, requiring a clarification on the Tender document shall notify Consulate General of India in Shanghai via email to [hoc.shanghai@mea.gov.in](mailto:hoc.shanghai@mea.gov.in) within the time-frame as indicated in the Data Sheet.
- ii. Consulate General of India in Shanghai will conduct the Pre-bid Meeting on 15.07.2021 at 1400 hours (China Time) virtually to address the submitted queries.
- iii. The pre bid meeting will be held at CISCO WEBEX platform. Interested bidders can obtain the meeting link and password by writing to the Head of Chancery at [hoc.shanghai@mea.gov.in](mailto:hoc.shanghai@mea.gov.in)

#### **(V) Bid system:**

A two-bid system (Technical & Financial Bids) will be followed. The Technical bids shall be opened at 1130 hours (China Time) on 03.08.2021, at HoC's office (Address: Consulate General of India, Shanghai) in the presence of those bidders who may desire to be present at that time. The Technical Bid/presentation will be evaluated by the Technical Evaluation Committee of the Consulate.

#### **Submission of Bids:**

Prospective bidders are requested to submit their bids in two parts, ie (I) Technical Bid and (II) Financial Bid. They should be sent in physical copy and/or by email to [hoc.shanghai@mea.gov.in](mailto:hoc.shanghai@mea.gov.in) with a copy to [ccons.shanghai@mea.gov.in](mailto:ccons.shanghai@mea.gov.in) and [vcons.shanghai@mea.gov.in](mailto:vcons.shanghai@mea.gov.in) . Procedure to be followed in either case is detailed below:

#### **(I) Technical Bid:**

The bidding agencies are required to submit the documents as detailed in annexure I. Only the bids complying with the Minimum Eligibility Criteria shall be allowed to participate in the technical presentation.

#### **(II) Financial Bid:**

The bidding agencies are required to submit the financial bid in the sample format, found in annexure II.

#### **(VII) Procedure for bid submission:**

#### **Physical Bids:**

The bidding agencies are required to submit technical and financial bids in two separate sealed envelopes superscribed as "Technical Bids" and "Financial Bid", which in turn is to be placed in an envelope sealed and superscribed as "Consulate General of India – Website Management". They are to be sent to the following address:

**Email Bids:**

The bidding agencies are required to send the Technical and Financial Bids via email to hoc.shanghai@mea.gov.in and vcons.shanghai@mea.gov.in in PDF format. The Technical Bid is to be sent as an open document and Financial Bid should be sent as a password protected PDF file along with Technical specifications. Those received in any other format and also without password protection will not be considered and will be summarily rejected. Technical Bids may also be sent by WeTransfer to the email IDs indicated above.

The password will have to be shared by the bidding agencies only on the date and time specified for opening of the Financial Bid, which will be intimated to the Technically Qualified Bidders following completion of Technical evaluation.

**(VIII) Minimum Eligibility Criteria:**

- i. Earnest Money Deposit (EMD) of US\$ 500/- (US\$ five hundred only) in the form of Demand Draft/Bank Guarantee in favor of Consulate General of India in Shanghai **OR** Bid Securing Declaration (BSD) in lieu of EMD, format of which is at Annexure II of the Tender Document.
- ii. The agency should hold valid PAN, Sales tax/GST/VAT registrations .
- iii. A minimum of three years of experience in the relevant area such as working with Indian Government websites, including Govt. of India undertakings websites, Embassy/ High Commission/ Consulate websites, portals applications and execution of a work of similar nature of projects value worth at least INR 1 Cr - per year, in the last three years.
- iv. The average annual turnover of the agency should be at least INR 3 Cr for the last three financial years. The agency is required to submit a certificate from its auditor to this effect. The turnover figures for the preceding three financial years should also be marked clearly on the balance sheet. Turnover figures only for complete (not partial) financial years shall be accepted. In case the agency has multiple business wings, turnover figures of only the software development /related branch shall be considered and the agency will have to submit the said figure.
- v. The agency should neither be blacklisted by any Govt. Department nor should any Criminal Case be registered against the agency or its owner or partners anywhere in India.
- vi. Agency must have filed Tax Returns for the last three years.
- vii. Agency must be at least a CMMI level 5 or 3 company. However ISO 9001:2015 (Quality Management) and ISO 27001:2013 (Information Security) may also apply.

**(IX) Evaluation of Bid:**

i. In the first stage, only the Technical Bid will be opened and examined. Only the bidders fulfilling the technical requirements will be selected for opening the Financial Bids. Other bids which do not qualify will not be processed further.

ii. Financial Bids of companies qualifying the technical evaluation will be opened in the next stage and the contract price shall be the criterion for selection of service provider. If the Contract price is same for one or more bidders, then the bidder graded higher in the Technical Evaluation will become eligible. Period of bid validity should be at least 180 days from the date of opening of Technical bid.

**(X) Technical Evaluation:**

Only the agencies who fulfill the Minimum Eligibility Criteria and submit the physical bids or email bids with all of the documents mentioned as per annexure I and as per the procedure laid out in Para (VIII) above shall be eligible for Technical Evaluation. Such agencies shall be required to undergo a Technical Evaluation.

As part of the technical evaluation, agencies will have to give a technical presentation to the Mission covering the points as mentioned in the table below. The technical evaluation of the bidders shall be made on the following points:

**The minimum qualifying score shall be 70.**

**(XI) Financial round:**

- i. Only the agencies who qualify the Technical evaluation round, will be eligible to participate in the financial bidding round. The date and time for opening of the Financial Bid will be intimated on a later date.
- ii. The bidder will quote their 'annual rate' (exclusive of applicable taxes) for carrying out the entirety of the scope of work. The rates shall be quoted in the BOQ sheet (a sample is provided with tender documents as Annexure II)
- iii. No change in financial bids is allowed after the last date of submission of tender documents.

**(XII) Terms & Conditions:**

- 1) Tender bids received after the closing date and time will not be entertained.
- 2) The Ministry reserves the right to extend the last date and time for submission of the bids on its own discretion.
- 3) The bidding agency shall bear all costs associated with the preparation and submission of its bids and the Consulate General of India in Shanghai will in no way be held responsible or liable for these



costs, regardless of the conduct or outcome of the bidding process. It is also clarified that no binding relationship will exist between any of the bidders and the Ministry until execution of a contractual agreement.

- 4) The bids shall remain valid for a period of 180 (One hundred and eighty) days from the date of submission.
- 5) Failure to furnish all the required information may result in rejection of the bid.
- 6) Agencies applying for the tender will submit a certificate that the information submitted by them is correct and they will abide by any decision of the Ministry. In case the information submitted by the agency is found to be false and/ or incorrect in any manner, the agency can be suspended and/or debarred.
- 7) Any notice by one party to the other, pursuant to the Contract shall be sent by e- mail/letter and confirmed in writing to the address specified for that purpose in the Contract.
- 8) To assist in Technical evaluation, the Consulate reserves the right to call for any clarification from any/all bidding agencies during the evaluation of the bids. Such clarification should be submitted only in writing. However no other correspondence on bids will be entertained.
- 9) Participation in this bid will imply that the bidder has accepted all the terms and conditions and subsequent modifications, if any, of this bid document.
- 10) The Consulate shall have the sole proprietary rights over the content created/edited/provided by the agency who has been awarded the contract through this tender.
- 11) In all matters related to dispute relating to this tender, the decision of this office will be final and binding upon the agency.
- 12) The Consulate reserves the right to accept or reject any or all bids without assigning any reasons at any stage of tender process. No bidders shall have any cause or claim against the Ministry for rejection of their bid.
- 13) Payment terms:
  - The Payment terms would be as follows:
    - 10% Advance.
    - 10% at the end of contract.
    - Balance Amount in equal instalments to be paid at the end of every quarter.
  - The price quoted shall remain fixed and not be subject to variations in exchange rate, duties, levies etc.
  - The agency who has been awarded the contract shall submit the bills within a week of expiry of the billing quarter.
  - Only applicable taxes shall be applied in addition to quoted rates.
- 14) Agency must procure and provide all the hardware and software required by its project team to enable them to meet the target assignment.
- 15) The Consulate expects the agency to engage professionals to undertake the project and reserves the right to call for resumes, documents relating to their professional background, expertise and their achievements .

16) Quality of work and completion of task within the time schedule (as notified with each assignment) are of paramount importance and any lapse may lead to cancellation of the contract with the agency without any further notice.

17) Notwithstanding any of the provisions mentioned above, for rates and other terms and conditions, in case of any disagreement etc., decision of the Ministry will be final and binding on all bidders participating in this bid.

**18) Earnest Money Deposit:**

- Bidders are required to submit an Earnest **Money Deposit (EMD)** of US\$ 500/- (US\$ five hundred only) as described in Annexure I. It must be delivered to the Consulate General of India in Shanghai in the form of Demand Draft/Bank Gurantee in favour of Consulate General of India, Shanghai.
- The bid security of unsuccessful bidders will be returned to them after the award of the contract. Earnest Money Deposit with Consulate General of India in Shanghai for the purpose of tender will earn no interest.
- **EMD** will be forfeited on account of one or more of the following reasons:-
  - i. The Bidder withdraws/modifies his bid during the period of bid validity.
  - ii. In case the selected bidder fails to sign the agreement in time and furnish performance bank guarantee.
- Alternatively, a Bid Securing Declaration (BSD) may be submitted in lieu of an EMD.

19) The Agency has to provide services on a 24 x 7 basis.

20) Bidders are required to upload documents exactly as described in Annexure I.

**(XIII) Performance Bank Guarantee:**

i. The successful bidder shall provide a Performance Guarantee for the due and faithful performance of contract for a sum of 10% of the total contract price before the signing of Agreement. The Performance Guarantee should remain valid for a period of 60 days beyond the date of completion of contractual obligations. Earnest Money Deposit of the successful bidder will be returned after submission of Performance guarantee.

ii. Refusal or inability or delay by successful bidder to supply all deliverables as per scope of work at the contracted rate may result in termination of the contract and forfeiture of Performance Guarantee (PG) as well as disqualification of the bidder from participating in future tenders.

**(XIV) Agreement deed:**

The successful bidder shall execute an agreement for the fulfilment of the contract at the time of award of contract. The incidental expenses of execution of agreement/Contract shall be borne by the successful bidder. Agreement/contract will be signed after the submission of the Performance Bank Guarantee (PBG) which shall be 10 percent of the contract value.

**(XV) Penalty Clause:**

(i) If the bidder withdraws or alters the bid before the expiry of bid validity period, Consulate may take the decision to forfeit the EMD and debar it from participating in future tenders .

(ii) If at any future point of time it is found that the bidder has submitted information which is factually incorrect or if the bidder does not fulfill any of the contractual obligations, the Consulate may take a decision to cancel the contract with immediate effect, and/or debar the bidder from bidding prospectively in this and all other tender procedures for a period to be decided by the Ministry and take any other action as deemed necessary. The penalty with respect to its time period shall be quantified by the Consulate at its own discretion/ satisfaction.

(iii) It would be the first and foremost responsibility of the service provider to ensure that the services are being provided satisfactorily and contract is executed as per agreed terms and conditions. In the event of delayed or unsatisfactory services, this Consulate may recover a sum from the service provider equivalent to a minimum of 0.5% of the price for any portion of services delayed/ negligence in service. The maximum amount which shall be recovered would be 10% of the price for any portion of services delayed/ negligence in service.

#### **(XVI) Settlement of Disputes and Arbitration:**

i. If any dispute, difference or question at any time arises between the Mission and the service provider in respect of the agreement signed which cannot be settled mutually or in case of termination as described in clause XVII, shall be referred to arbitration.

ii. The arbitration proceedings will be conducted in accordance with and be subject to the UNCITRAL (United Nations commission on International Trade Laws) Arbitration Rules, as amended from time to time and the decision of the arbitrators as mentioned above shall be final and binding on the parties.

iii. The Arbitration will have its sittings in New Delhi, India.

#### **(XVI) FORCE MAJEURE:**

i. The Ministry may consider relaxing the penalty and delivery requirements, as specified in the tender document, if and to the extent the delay in performance or failure to perform its obligations under the contract is the result of Force Majeure.

ii. Force majeure as used herein means any unforeseeable and irresistible act of nature, any act of war (whether declared or not), invasion, revolution, insurrection, terrorism, or any other acts of a similar nature or force, provided that such acts arise from causes beyond the control and without the fault or negligence of the service provider.

iii. In the event of and as soon as possible after the occurrence of any cause constituting force majeure, the affected Party shall give notice and full particulars in writing to the other Party, of such occurrence or cause if the affected Party is thereby rendered unable, wholly or in part, to perform its obligations and meet its responsibilities under the Contract.

iv. The affected Party shall also notify the other party of any other changes in conditions or the occurrence of any event which interferes or threatens to interfere with its performance of the Contract. On receipt of the notice or notices required hereunder, the Party not affected by the occurrence of any cause

constituting force majeure shall take such action as it reasonably considers being appropriate or necessary in the circumstances, including granting the affected Party of a reasonable extension of time in which to perform any obligations under the Contract.

v. If the service provider is rendered unable, wholly or in part, by reason of force majeure to perform its obligations and meet its responsibilities under the Contract, the Consulate General of India in Shanghai shall have the right to suspend or terminate the Contract on the same terms and conditions with immediate effect. In any case, the Consulate shall be entitled to consider the service provider permanently unable to perform its obligations under the Contract in case the service provider is unable to perform its obligations, wholly or in part, by reason of force majeure.


**(XVII) Liquidated damages and termination:**

i. In case of quality of service provided by the service provider found wanting / inadequate, the competent authority may terminate the contract agreement after giving 15 days' notice. In that case the competent authority may forfeit the Performance Guarantee deposit .

ii. In case of a material breach of any of the terms and conditions mentioned in the tender document, the competent authority will have the right to terminate the contract, cancel the work order without assigning any reason and nothing will be payable by this Ministry in that event in that event and the Performance security deposit may also be forfeited .

**(XVIII) Closure of Contract:**

A "No Claim Certificate" shall be furnished by the service provider as per format given in Annexure IV of tender document, while making the final payment and before the release of Performance Bank Guarantee.
