**TERMS & CONDITIONS:**

**1. Scope of work:**

The External Publicity & Public Diplomacy Division of the Ministry of External Affairs (MEA) invites proposals from film producers/distributors for purchase of screening rights of the following Bollywood and Indian regional feature films:-

These films should be provided in formats like DVD, Blu Ray, and Hard Drive/DCP. These films should be subtitled in English (each in separate DVD, Blu Ray, Hard Drive, and Digital Cinema Package). The films are required for screenings abroad on non-commercial/non-profit/non-exclusive screening rights basis for promotion of Indian cinema abroad and also for holding film festivals/film weeks through Indian Missions/Posts abroad. Distributors provide dubbing and subtitling rights of these films in all foreign languages such as French, Spanish, and Arabic, German & Portuguese. However, if a Bidder is able to offer films subtitled/dubbed in any foreign language(s), he/she may indicate the additional cost for subtitling/dubbing in foreign language (language- wise) in a separate sheet. The films should be offered with cue sheets in English & Hindi along with the script.

## **2. Eligibility criteria:**

Bidder/authorized representatives should provide evidence of having necessary ownership rights of the films. If the bidder is not the direct buyer of screening rights from the producer of a film, then all supporting documents linking the chain of transfer of screening rights have to be submitted. In case more than one film is being offered, the rate of each film should be mentioned separately. It is mandatory for the bidder to meet all conditions of this RFP.

## **3. Technical specifications/deliverables:**

Successful bidder must supply the best HD print of the following deliverables for use, and, if offered with subtitling/dubbing in foreign languages, to enable dubbing/subtitling in other languages and conversion to other formats within 60 days of being declared successful bidder:

- a) High Definition (HD) Mixed Master with English subtitles.
- b) High Definition (HD) Unmixed Master in Hard Drive in original with script / dialogue sheet (time coded) from the original languages of the films into English subtitles/dubbing.
- c) DVD Copy in .Mov format (not exceeding 2 GB) of the Master (unmixed and mixed) with English subtitles -five copies of each.
- d) DVD in .mp4 Format of the master and subtitled versions in English - two copies of each.
- e) Soft copy (Word document in CD/DVD) of approved script, cue sheet, synopsis, .....lyrics in Hindi and English language.
- f) One DCP (Digital Cinema Package) of each film.
- g) Blu Ray DVDs (Original and Subtitled) of each film- five copies each.
- h) Original soundtrack of the film in a Hard Drive.
- i) Design covers and publicity posters of the film (around 20-25), inlay design work.
- j) Trailer Video of the film

## **4. Price, EMD, and Performance guarantee:**

i) The price quoted should be the full amount, including all taxes, against all deliverables. An amount of Rs. 9,00,000/- (Rupees Nine Lakh only) will have to be deposited as an **Earnest Money Deposit (EMD)** which is 3% of estimated tender value with the bids in the form of a **bank demand draft or bank guarantee valid for a period of 45 days** beyond the final bid validity period. Estimated tender value will be approx three crore. This EMD should be scanned and attached with the RFP documents to be submitted online. No bids will be accepted without requisite EMD. This EMD along with the hard copy of entire proposal should be sent in original to the undersigned after successful online submission of the bids. The EMD will be refunded within one month of the date of announcing of award of the contract. No claim of interest will be entertained by MEA in case of delayed payments for reasons beyond its control.

ii) "Micro and small Enterprises (MSEs) as defined in MSE Procurement Policy issued by Departments of Micro, Small and Medium Enterprises or are registered with the Central Purchase Organization or the concerned Ministry or Department are not required to submit EMDs". MSEs seeking EMD exemption must submit its MSME certificate.

iii) Successful bidder will have to deposit Bank **Performance Guarantee** in shape of a **bank demand draft or bank guarantee** in favour of **PAO, COA, MEA, New Delhi** equivalent to **3% (three percent)** value of the contract in case of each vendor within fifteen (15) days of award of the contract, **valid upto 60 days after the completion of the tenure of contract period**. EMD, Demand Draft, or Bank Guarantee deposited with MEA shall earn no interest.

#### 5. **Submission of proposals:**

Bidder should upload their bids on GeM Portal in two separate parts:  
Technical and Financial Bid

#### 6. **Evaluation procedure:** Evaluation of the Technical and financial bids:

- a) Technical Bids: Only those agencies which submit all the documents as specified in para 6, Annexure 1- 11 will be technically qualified and eligible for financial evaluation.
- b) Financial bids: Lowest price per film (L1) will be recommended for acceptance.
- c) Bids are to be submitted online by **03.11.2022 (1800 HRS) as per BOQ files attached with the RFP**. Bids will be opened on **04.11.2022 at 1100 hrs** in presence of Film selection Committee, interested bidders can also participate. **Selection will be made by a Film Selection Committee whose decision will be final and binding on all**. Lowest price per film (L-1) will be recommended for acceptance. **However Ministry has reserved rights to negotiate with the L1 bidders if quoted price seems higher**. Bids should be submitted in online mode only. MEA reserves the right to relax any term or condition of this RFP at any stage of tender process with the approval of the competent authority. Bids should be submitted duly sealed/stamped with signature of bidder/authorized representative attaching the following in a scanned .pdf file:

- (1) A covering page stating all Annexure attached with the technical

- bid as detailed below (A/1).
- (2) Notarized copy of ownership document of the film; or in cases of authorized representatives an authority letter in original from the owner/films' right holder. Complete name, office address, and branches if any should be mentioned (A/2).
  - (3) Notarized affidavit in original on Rs. 100/- stamp paper affirming/confirming to be the owner/authorized representative/ rights holder by bidder and eligible to bid as he/she meets all conditions of this EOI notice and is not disqualified by any disqualification mentioned in the EOI notice (A/3).
  - (4) Details of link agreements to ownership document (A/4).
  - (5) Particulars of the bidder in the prescribed format (A/5).
  - (6) Notarized affidavit declaring that screening of film abroad is free from all encumbrances (A/6)
  - (7) Notarized indemnity bond on Rs. 200/- stamp paper (A/7)
  - (8) An amount of Rs. 9,00,000/- (Rupees Nine Lakh only) will have to be deposited as an Earnest Money Deposit (**EMD**) with the bid after scanning it in the form of a bank Demand Draft *valid for a period of 45 days* from last date of submission in favour of the **"Pay and Accounts Officer, Ministry of External Affairs"** payable at New Delhi (A/8). The same should be deposited in original to the undersigned on or before the last date of submission of bids.
  - (9) Tax returns for the last three years (2019-2021) and copies of PAN/TAN/Service Tax numbers, as applicable (A/9).
  - (10) Copy of the terms and conditions duly signed by authorized signatory as a token of acceptance of the same (A/10).
  - (11) Any additional information from the bidder which is relevant to the offer (A/11).

## 7 **Instruction to Bidders:**

A Bidder should meet prescribed eligibility criteria and observe conditions of this RFP. Offer should be valid for at least 180 days from the last date of submission of RFP. The bids should be submitted online on or before **1800 hrs on 03.11.2022**. MEA reserves the right to accept or reject all or any of the bids without assigning any reason. Incomplete applications will be liable to be rejected. As per GFR Rule, Bidders should not be permitted to alter or modify their bids after expiry of the deadline for receipt of bids. Bidders should mention their complete office address along with Email Id and contact details.

## 8. **Contract/Notification of Award/ Letter of Acceptance of Award:**

MEA will notify the successful bidder(s) by e-mail and confirm through letter on the address provided, that his/her bid has been accepted. This '**Notification of Award**' shall quote the amount which MEA will pay to the bidder in consideration of the performance of the **Scope of Work** by the bidder. The successful bidder(s) on receipt of "Notification of Award" shall convey his '**Acceptance of Award**' by return e-mail which will be confirmed *through speed post letter within seven*

(07) *Business days*. The Notification of Award and the letter of Acceptance of Award shall constitute the contract.

## 9 Terms & Condition:-

- a) Mere submission of the proposal shall not confer any right whatsoever on the submitting entity/bidder.
- b) It shall be obligatory on part of the submitting entity / bidder to furnish any further information as may be sought by MEA.
- c) No amendments/ changes will be allowed after the last date of submission of bids.

### 10.a) **Forfeiture of EMD: - EMD will be forfeited on account of one or more of the following reasons:**

- i) The bidder withdraws his/her bid during the period of bid validity.
- ii) In case of a successful bidder, the selected bidder fails to sign the agreement in time and furnish performance security.

**b) Termination/Penalty clause:** Refusal or inability or delay or any false statement by the successful bidder to supply all deliverables as per Scope of Work at the contracted rate within prescribed time frame may result in termination of the contract and forfeiting of EMD/Bank Performance Guarantee as well as disqualification of the bidder from participating in future tenders. MEA will have the right to take any other action as deemed necessary. Withdrawal of a bid after its submission can result in the forfeiture of the EMD. The bidder is bound to provide high quality of feature films and good quality of sub titling and dubbing in Indian regional and foreign languages. If MEA finds the quality of film or sub-titling and dubbing services lacking in quality, bidder will be bound to re-submit the films in desired quality of picture and sub tiling / dubbing without any additional cost to MEA in a time bound period as specified by MEA

### **Disqualification:**

Incomplete applications without applicable Annexure may render a bidder disqualified. Even though a bidder may meet eligibility criteria, he/she is subject to be disqualified if any bidder/authorized representative have:

- (a) Made misleading or false representation in the forms, statements and attachments submitted; or
- (b) Had previous record of poor performance during the last 03 (three) years, as on the date of application such as rescinding of contract for which the reasons are attributable to the non-performance, inordinate delays in performance; or
- (c) If a bidder has a criminal history or has been convicted by any court of law for any of the offences under any Indian law in last ten years.

11 **Period of Screening Rights:** The period of validity of procured Films will be Five years from the date of contract signed.

12. **Force Majeure Clause (FMC):** A force Majeure means Extraordinary<sup>8</sup> events or circumstances beyond human control such as an event described as an act of God (like a natural calamity ) or events such as a war, strike, riots, crimes (but not including negligence or wrong – doing, predictable/ seasonal rain and any other events specifically excluded in the clause). An FM clause does not excuse a party's non-performance entirely, but only suspends it occurs and it cannot be claimed ex-facto.

13 **Acceptance/ Rejection of bids:**

MEA reserves the right to reject any or all of the bids or to modify or cancel the RFP as and when deemed necessary.

14 **Jurisdiction of courts:**

Any dispute arising out of this RFP shall be governed and settled in accordance with the laws of India and the courts in NCT of Delhi shall have exclusive jurisdiction in relation thereto.

15 **Contact details:**
