SECTION I: INSTRUCTIONS TO BIDDERS

High Commission of India Mbabane

Subject: Tender invitation for hiring of two (02) local security guards (LSGs) by the High Commission of India, Mbabane.

High Commission of India, Mbabane invites sealed tenders (two-bid system) from reputed security agencies for hiring of two (02) security guards for India House at Lot No. 2593, Magwava Street, Thembelihle, Mbabane.

Bidders are also required to deposit Earnest Money Deposit (EMD) of E 5650 (Emalangeni five thousand six hundred and fifty only) in the form of "Pay Order/Demand Draft or Bank Guarantee from any Scheduled bank of Eswatini" in favour of "High Commission of India, Mbabane". Bids received without EMD will not be considered and rejected summarily.

- 3. The tender should be submitted in separate sealed envelopes as below along with prescribed EMD.
- (a) The first sealed envelope superscripted as "Technical Bid" should contain relevant documents and specifications only.
- (b) The second sealed envelope superscripted "Financial Bid" should contain only rates for the proposed service.
- (c) The third envelope superscripted as EMD should contain EMD in the form of "Pay Order/Demand Draft or Bank Guarantee from any Scheduled bank of Eswatini"
- (c) All the sealed envelopes and the EMD envelope should be placed into another envelope, sealed and superscripted "Tender for providing two (02) security guards" addressed to the Head of Chancery, High Commission of India, Quadrant B&C, UN House, Somhlolo Road, Mbabane, Kingdom of Eswatini and must reach on or before 25 April 2024 by 1600 hrs. Bids may be hand delivered or sent by speed post at the aforementioned address so as to reach on or before the prescribed date and time. Mission will not be responsible for any postal delay.

- 4. The Post reserves the right to reject any or all applications/offers without giving any notice or assigning any reason thereof. The decision of the Mission in this regard will be final and binding upon the bidders.

SECTION II: CONDITIONS OF CONTRACT

- 1. The Annual Security Contract would be in effect for two years period subject to further review where necessary.
- 2, Bidders are required to deposit Earnest Money Deposit (EMD) E 5650 (Emalangeni five thousand six hundred and fifty only) form of "Pay Order, Demand Draft or Bank Guarantee from any Scheduled bank of Eswatini" in favour of "High Commission of India, Mbabane, Bids received without EMD will not be considered and shall be rejected summarily. EMD of all unsuccessful bidders shall be refunded within 30 days of awarding the tender. No interest shall be payable for EMDs.
- 3. The Tender which shall be valid for a minimum of 90 days from 25 April 2024 may please be neatly arranged, plain and intelligible. Each page of the Tender should be signed. They should not contain any terms and conditions, printed or otherwise, which are not applicable to the Tender. Any conditional tender will be summarily rejected. Insertions, postscripts, additions, and alterations shall not be recognized, unless confirmed by bidder's signature.
- 4. The Bidders shall submit documentary evidence in respect of their technical capabilities and the Financial Bid including their experience in execution of similar nature of work.
- 5. Any tender received by HCI, Mbabane after the deadline for submission of tenders, will not be accepted and returned unopened to the bidder.
- 6. Interpretation of the clauses in the Tender Document/Contract Document. In case of any ambiguity/ dispute in the interpretation of any of the clauses in this Tender Document, HCI, Mbabane's interpretation of the clauses shall be final and binding on all parties.
- 7. The successful bidder, on award of contract, must send the contract/acceptance in writing, within seven (7) days of award of contract, failing which the EMD will be forfeited, and the order will be placed to the next successful bidder. The EMD shall also be forfeited if the bidder withdraws the tender during the period of tender validity specified in the tender.
- 8. Mission reserves the right to terminate the contract at any point in time during the tenure of the contract if the services are not found satisfactory or the contractor dishonors the contract. Decision of the Mission in this regard shall be final and binding upon the contractor.

SECTION III: SCHEDULE OF REQUIREMENTS

1. Prices

- a. Price quoted by the Contractor and agreed to by HCI, Mbabane shall be considered final, and no price escalation will be permitted thereafter.
- b. Bidders must quote the price in the format given in the Contract Price Schedule in Section V of this document.
- c. All prices are to be quoted only in Emalangeni.

2. Taxes and Duties:

The prices quoted should be inclusive of all taxes and duties, if applicable in Mbabane.

3. Performance Bank Guarantee (PBG):

The successful bidder will be required to furnish the Performance Bank Guarantee in the form of a Bank Guarantee of 10% (ten percent) the amount of the accepted Contract Price within two (2) working days of receipt of award of contract. This bank guarantee shall remain valid till the expiry of the assigned job.
