# Subject: Information sought under Right to Information Act, 2005.

Sir,

Reference to your Applications No. MOEAF/R/2018/00107 dated 06/02/2018 and MOEAF/A/2018/00007 dated 12/04/2018 seeking information under Right to Information Act 2005.

2. You have sought information as given below:-

- (a) Complete list of the ASEAN Delegations, participated during the eve of Republic Day 2018.
- (b) Complete details of the all kind of the expenditure, which is bear by the India Government.
- (c) Further, to Question No. (2), please provide information containing complete details of he entire expenditure take place on all arrangements from A to Z, which include boarding, lodging, copies of the hotel bills, invoices.
- 3. The following is the response of the CPIO:-
  - (a) With reference to your request for information mentioned at 2 (a) above, it is submitted that the information sought cannot be provided under section 8 (1) (a) and (f) of the RTI Act, 2005. The details sought are the subject matter between Government of India and a Foreign State. The Subject matter involves the information received in confidence from a foreign Government and cannot be disclosed.
  - (b) With reference to your request for information mentioned at 2 (b) and (c) above, It is submitted that revelation of the information sought would have unintended effects on the foreign relations and that any critical analysis/ scrutiny and comparison of the expenditure incurred on foreign dignitaries who participated in the Summit would be totally undesirable and would defeat the very purpose of generating goodwill between the nations. Disclosure of this information may prejudicially effect India's relations with the concerned foreign state, exemption is therefore, sought under section 8 (1) (a) of the RTI Act 2005, wherein no such information as may prejudicially affect India's relations with a foreign state need be disclosed.

4. ## The appellant respectfully submits, as under:

That appellant had filed the RTI, Application dated 30.01.2018, with CPIO, consist with 'three questions' (Copy enclosed as Annexure-A), and subsequently, received letter/reply Dated 07.02.2018 (Copy enclosed as Annexure-B), whereby, application was transferred with CPIO, DS (ASEAN-ML), (MEA) and thereafter, information was not provided and being aggrieved consequently, undersigned is filing the present First Appeal under Section 19 (1) of the RTI, Act 2005 on the following grounds, as under:
