- The applicant should be in the age group of 30-40 years of age as of the last date of submission of the application. However, age may be relaxed upto 5 years both at lower and upper ends i.e. 25-45 years in special/exceptional qualification/experience.

The contract may be terminated on one month's notice from either side or on payment of one month's pay in lieu thereof. Unauthorized absence may lead to termination of the engagement.

Nature of Duties	:	<ul style="list-style-type: none">• The selected NEST Fellow will be required to work in the Ministry's New, Emerging & Strategic Technologies (NEST) Division in the Ministry which looks after matters related to technology diplomacy.• His/Her duties will entail gauging new emerging strategic and critical technologies and their relevance to India's development, economic growth, and national security.• This may include regularly monitoring information on technology innovation and international normative frameworks, technology governance rules, and standards being deliberated by countries, as well as providing knowledge-based inputs.• Assisting in analyses of national security and legal implications of new, emerging, strategic and critical technologies and technology-based resources.• Assisting in the assessment of demand-driven requirements of new emerging and strategic technologies in the country, help in identify new emerging technologies of relevance to India, and assessing the potential for collaboration.• Analyse published material on new emerging and strategic technologies.• Assist in organising and participating in meetings, workshops, seminars, and conferences relevant to the work of the NEST Division and submitting reports on them.
