


Minutes of the meeting for recommending candidates for appointment on compassionate grounds to the posts of JSA and MTS for the Recruitment Year 2020-21


In terms of DoP&T's O.M. No. F.No. 14014/02/2012-Estt. (D) dated 16.01.2013, 5% of the vacancies falling under DR quota of JSA and MTS posts, are assigned for appointment on compassionate grounds.


2. Cadre Cell of the Ministry had informed that 1 post of JSA and 2 posts of MTS are available to be filled under this quota for recruitment year 2020-21.
3. The Committee constituted to screen and recommend candidates for compassionate appointment to the posts of JSA & MTS out of 31 eligible candidates met on 30th December, 2021 at 3:30 pm in Room No. 70, South Block, New Delhi under the chairmanship of Sh. Kartik Pande, Joint Secretary (IOR).
4. As per new guidelines of DoPT (F.No.43019/9/2019-Estt(D) dated 23.08.2021), candidates have not been called for personal hearing this year. The point based merit system was published on MEA website and Unique Registration Numbers (URNs) have been communicated to the eligible candidates.
5. The Committee shortlisted the candidates based on the criteria evolved to gauge financial penury based on the following approved parameters:
 - (i) Family Pension.
 - (ii) Terminal Benefits (Gratuity).
 - (iii) Left-over Service of the Deceased (in years).
 - (iv) Size of family & additional points.
 - (v) Monthly Income of all the dependent members of the Deceased's family (including the applicant) (includes income from all sources like house property/rental income/commercial property, agricultural income, salary/wages, bank interest etc. but excludes family pension).
 - (vi) Rented/owned property(house).
 - (vii) Postings done by deceased government employee.
6. The Committee, based on the criteria as explained in para 5 above and within the overall ambit of financial penury, drew up a list of the following eligible candidates in order of merit for appointment to the posts of JSA(1) and MTS(2) based on their suitability/eligibility for such posts:




7. The Committee also recommended to keep panel as per seniority list, in case selected candidates do not accept the offer for appointment.


