(a) to (e) Government's position on China's 'One Belt One Road' (OBOR) or 'Belt and Road Initiative' (BRI) has been clear and consistent.

Government's concerns arise in part from the fact that the inclusion of the so-called illegal 'China-Pakistan Economic Corridor' (CPEC) as a flagship project of 'OBOR/BRI', directly impinges on the issue of sovereignty and territorial integrity of India. This so-called illegal 'China-Pakistan Economic Corridor' (CPEC) passes through parts of the Union Territories of Jammu & Kashmir and Ladakh which are under illegal occupation of Pakistan. Government has conveyed its concerns to the Chinese side about their activities in areas illegally occupied by Pakistan in the Union Territories of Jammu & Kashmir and Ladakh and has asked them to cease such activities.

Further, the Government is of the firm belief that connectivity initiatives must be based on universally recognized international norms. They must follow principles of openness, transparency and financial responsibility and must be pursued in a manner that respects sovereignty, equality and territorial integrity of other nations.

Government's consistent position in this regard has also been endorsed by other countries. The India-USA Joint Statement 'Prosperity through Partnership' released in June 2017 called upon all nations to support bolstering regional economic connectivity through transparent development of infrastructure and the use of responsible debt financing practices, while ensuring respect for sovereignty and territorial integrity, the rule of law and the environment.

The India-Japan 'Prosperity through Partnership' released in September 2017 also underlined the importance of all countries ensuring the development and use of connectivity infrastructure in an open, transparent and non-exclusive manner based on international standards and responsible debt financing practices, while ensuring respect for sovereignty and territorial integrity, the rule of law, and the environment.

The European Commission issued a Joint Communication in September 2018 titled 'Connecting Europe and Asia – Building blocks for an EU Strategy' in which it has been highlighted that the European Union promotes an approach to connectivity, which is sustainable, comprehensive and rules-based. Connectivity has to be economically, fiscally, environmentally and socially sustainable in the long term.

- (a) The current stance of the Government on China's One Belt and One Road Initiative (BRI);
- (b) Whether the Government plans to use economic development projects as a foreign policy tool in South Asia, South-east Asia and Africa;
- (c) If so, the planned investment therein; and
- (d) If not, the strategies in place to counter BRI's economic and foreign policy influence among India's strategic Asian and African partners?

# ANSWER THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS [SHRI V. MURALEEDHARAN]

(a) Government's position on China's 'One Belt One Road' (OBOR) or 'Belt and Road Initiative' (BRI) has been clear and consistent. The inclusion of the so-called 'China-Pakistan Economic Corridor' (CPEC), which passes through parts of the Indian state of Jammu & Kashmir under illegal occupation of Pakistan, as a flagship project of 'OBOR/BRI', reflects


lack of appreciation of India's concerns on the issue of sovereignty and territorial integrity. Government has conveyed to the Chinese side its concerns about their activities in Pakistan Occupied Jammu & Kashmir and asked them to cease these activities.

Expansion and strengthening of connectivity is an integral part of India's economic and diplomatic initiatives. At the same time, Government is of the firm belief that connectivity initiatives must be based on universally recognized international norms. They must follow principles of openness, transparency and financial responsibility and must be pursued in a manner that respects sovereignty, equality and territorial integrity of nations.

(b) to (d) India has a robust development cooperation agenda that constitutes a significant dimension of its close and multi-faceted ties with many partner countries, including in India's neighbourhood. Extension of Government of India (Gol) Lines of Credit (LOCs) on concessional terms is an important component of this development partnership in diverse areas of socio-economic development such as power, transport, connectivity, agriculture and irrigation, manufacturing industries, water and sanitation, healthcare etc.


As part of the Gol LOC programme, 279 LOCs have been extended to 63 countries of Asia, Africa, Latin America, Caribbean, Oceania and Commonwealth of Independent States worth nearly US\$ 28 billion. Of this, 254 projects aggregating nearly US\$ 4.70 billion have been completed, while 194 projects worth nearly US\$ 19 billion are under implementation. These include 94 connectivity projects in five countries in India's immediate neighbourhood being taken up with Gol LOC worth nearly US\$ 6.6 billion.



The European Commission issued a report in March 2019 titled 'EU-China- A Strategic Outlook' in which it has been highlighted that Chinese investments in third countries frequently neglect socioeconomic and financial sustainability and may result in high-level indebtedness and transfer of control over strategic assets and resources.



# Official Spokesperson's response to a query on participation of India in OBOR/BRI Forum

May 13, 2017

Responding to a query on participation of India in OBOR/BRI Forum, the official spokesperson said:

We had received formal invitation to participate in the 6 separate forums that China is organizing as part of the Belt and Road Forum being held in Beijing on May 14-16, 2017.

We are of firm belief that connectivity initiatives must be based on universally recognized international norms, good governance, rule of law, openness, transparency and equality. Connectivity initiatives must follow principles of financial responsibility to avoid projects that would create unsustainable debt burden for communities; balanced ecological and environmental protection and preservation standards; transparent assessment of project costs; and skill and technology transfer to help long term running and maintenance of the assets created by local communities. Connectivity projects must be pursued in a manner that respects sovereignty and territorial integrity.

India shares international community's desire for enhancing physical connectivity and believes that it should bring greater economic benefits to all in an equitable and balanced manner. We are working with many countries and international institutions in support of physical and digital connectivity in our own immediate and near neighbourhood.

Expansion and strengthening of connectivity is an integral part of India's economic and diplomatic initiatives. Under the 'Act East' policy, we are pursuing the Trilateral Highway project; under our 'Neighbourhood First' policy we are developing multimodal linkages with Myanmar and Bangladesh; under our 'Go West' strategy, we are engaged with Iran on Chabahar Port and with Iran and other partners in Central Asia on International North South Transport Corridor. BBIN initiative is aimed at enhancing logistics efficiencies in South Asian region. We are also actively considering acceding to TIR Convention.


Guided by our principled position in the matter, we have been urging China to engage in a meaningful dialogue on its connectivity initiative, 'One Belt, One Road' which was later renamed as 'Belt and Road Initiative'. We are awaiting a

positive response from the Chinese side.

Regarding the so-called 'China-Pakistan Economic Corridor', which is being projected as the flagship project of the BRI/OBOR, the international community is well aware of India's position. No country can accept a project that ignores its core concerns on sovereignty and territorial integrity.



In response to a query on media reports regarding possible cooperation with China on OBOR/BRI, the Official Spokesperson said:


"We have seen some media reports alluding to our possible cooperation with China in 'One Belt One Road' (OBOR)/'Belt and Road Initiative' (BRI).
