The information pertaining to the undersigned CPIO is as follows:

China is under occupation of approximately 38,000 sq. Kms of Indian territory in the States of Jammu & Kashmir and Ladakh. In addition, under the so-called China-Pakistan "Boundary Agreement" signed between China and Pakistan on 2 March 1963, Pakistan illegally ceded 5,180 sq. kms. of Indian territory in Pakistan Occupied Jammu & Kashmir to China.

3. If you are aggrieved with this reply, you may file an appeal to Dr. Amit Telang, Director (East Asia) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi – 110011, within a month from the date of receipt of this letter.
