Please refer to your RTI application dated 8 February 2020 addressed to RTI Cell, Ministry of External Affairs, New Delhi.

2. The information with respect to Points No. 1 & 2 pertaining to the undersigned CPIO is as follows:

The Government of India organized three special flights on January 31, February 1 and February 26 to evacuate 766 persons, which included 723 Indian nationals and 43 foreign nationals from the city of Wuhan as well as other cities of Hubei Province in China in view of the continuing lock down of the Hubei Province.

3. Other parts of your query do not pertain to the undersigned CPIO. Your RTI application is being transferred to Ministry of Health and Family Welfare and Under Secretary (Japan) in the Ministry of External Affairs for further necessary action.
