2. Reply to your RTI application is as under:

Proposed answer:

The Ministry communicated the reasons of disqualifications to PTOs and all PTOs were requested to submit clarifications by 12th August 2013. All the reasons/clarifications submitted by disqualified PTOs were scrutinized by C.A. firm under the supervision of a four member committee constituted for this specific purpose. Based on documents submitted by PTOs as also their oral clarifications, the final list of qualified PTOs, inline with the PTO policy for Haj 2013-17 duly approved by Hon'ble Supreme Court of India was published.

3. If you are aggrieved with the reply, you may file an appeal with Shri Mridul Kumar, JS (Gulf & Hajj), Ministry of External Affairs, South Block, New Delhi, within a month from the date of receipt of this letter.
