2. Your application was forwarded to this Division i.e. West Asia and North Africa Division (WANA Division) of the Ministry of External Affairs by RTI Cell, Ministry of External Affairs vide OM No. RTI/551/1076/2014 dated 25.08.2014.

3. In so far as WANA Division of the Ministry of External Affairs is concerned the information as sought by you cannot be provided in terms of para 7 (9) of Right to Information Act, 2005 as providing information

sought by you would disproportionately divert the resources of the public authority.

4. It may be stated that if you are not satisfied with the above response, an appeal could be sent by you to Shri Sandeep Kumar, Joint Secretary (WANA) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi, within thirty days of the receipt of this letter.
