- 9). There is no cost of travel involved as the media persons accompanied the Prime Minister on the special flight. The expenditure on accommodation etc. was borne by the concerned Department/Media organization i.e. Prasar Bharti in case of Doordarshan and All India Radio, Ministry of Information and Broadcasting in case of Photo Division and the private Agencies viz PTI, ANI, UNI made payments of their hotel accommodation rents directly to the hotels.
