- (3). It is requested to provide me the copy of the accord signed between Indian Govt and Sri Lankan Govt. for the help of Indian Army in Sri Lanka as "Peace Keeping Force"
- (4). It is requested to let me know the number of soldiers with their rank and name who sacrificed their life in Sri Lanka during peace keeping operations.
- (5). It is requested to let me know the amount of compensation as paid to each of the soldiers with their name and rank and detail of rehabilitation provided to their families.


