With reference to the above I am to state that as per the Office Memorandum cited in third reference by the Ministry of Personnel, Public Grievances and Pensions, Dept. of Personnel and Training, Establishment (Reservation) Section, Govt. of India, wherever it is found that a Government servant had furnished a false certificate for securing appointment, he should not be retained in service and also in no circumstances subjected for penalty.

Further to submit that the same has been reiterated through OMs cited in Ref.1 & 2. If one has become a permanent Government servant, an inquiry as prescribed in Rule 14 of CCS (CCA) Rules, 1965 may be held and if the charges are proved, the Government servant should be removed or dismissed from service. In no circumstances should any penalty be imposed.

*In the above circumstances it is requested to furnish the following details year-wise for the past two decades as per annexure provided:*

1. Category-wise no. of candidates who have produced false certificates and appointed.
2. Category-wise no. of employees terminated
3. Category-wise no. of cases pending. If so reasons for the same.
4. Details of Action Taken Report.
