Please refer to your RTI application dated 26/11/2014, received on 02/12/2014 seeking information under the RTI Act, 2005.

2. The reply is given below ad seriatum:-

i). As per RTI Act only a citizen of India is empowered to seek information under this Act and OCI/PIO card holders are primarily foreign nationals and therefore cannot seek information under the same.

ii). As stated in point (1) above, any Indian citizen can obtain information through an RTI as defined under section 2(f) of the Act, held by a public authority or under the control of that public Authority. However, in case the information asked for falls under the category of 'third party information' the relevant provisions of the RTI Act will be applicable.
